Rules and Regulations Pertaining to the Playdowns and Championships. <u>Laws of the Sport of Bowls</u>, Bowls USA, Domestic Regulations, Crystal Mark Third Edition

106 REQUIREMENTS for EACH ENTRY

- 106.1 Lawn bowlers wishing to compete in a Divisional Playdown which will determine that Division's Representatives to the National Championships must be:
 - 106.1.1 A citizen of the United States;
 - 106.1.2 A Bowls USA member prior to the Playdowns;
 - 106.1.3 Financially in good standing for all bowls-related obligations;
 - 106.1.4 Able to certify, if a member of more than one division, that they have not entered the Playdowns in any other Division;
 - 106.1.5 Willing to certify that they will compete at the Championships as that Division's representative or as the runner(s)-up in case of default by the winners;
 - 106.1.6 Aware that any Playdowns winner(s) who do not fulfill the above requirements may face possible sanctions from their Division.

106.2 Proof that any of the above requirements have not been fully met can be considered as cause for disqualification.

108 SUBSTITUTIONS

108.1 During Playdowns, no substitutions shall be permitted once play has commenced.

Additional Rules Pertaining to the Playdowns in the Central Division

- 1. The Pairs competition shall be completed before the Singles.
- 2. The winners of the Pairs are ineligible to participate in the Singles.
- **3.** All entries shall be made on the official entry form and the entry fee paid and submitted/ postmarked before the deadline for such entry.

General Playdowns Tournament Information

- The Executive Board shall establish and maintain guidelines for the conduct of the Division Playdowns, including dates, venue, format, entry fees, and the appointment of a Playdowns Coordinator.
- 2. The Playdowns Coordinator will determine the starting time for play on each day, determine the number of games to be played each day, be responsible to create the draw, determine umpires for the tournament, tabulate results and inform the Secretary-Treasurer of the final results.
- 3. All events must determine a winner and a second place or alternate finisher.
- 4. Bowls USA rules as spelled out in the latest edition of the <u>Laws of the Sport of Bowls</u> shall apply to the conduct of play.

Format for Playdowns Tournament

The format for both Singles and Pairs will be dependent on the number of entries.

- 1. *One entry:* the entrant(s) are declared the winners and no games need to be played. There is no second place or alternate finisher.
- 2. *Two entries:* a double round robin shall be played. In the event of a tie after two games, a third complete game will be played to determine the winner.
- 3. *Three or four entries:* a complete round robin shall be played. Pairs teams/Singles with one or no loss in the round robin will compete in a playoff. Those with two losses in the round robin will not advance.

- a. Playoff scenarios are detailed in Appendix A.
- b. In the event of a tie for first place, plus points for/against will be used to determine the seeding for the playoffs.
- c. In the event of a tie for second place, plus points for/against will be used to determine the second place or alternate finisher.
- 4. Five to eight entries (Pairs) / Five to ten entries (Singles):
 - a. A complete round robin shall be played. The team/player with the best won-loss record in the round robin will be declared the winner.
 - b. In the event of a tie for first place, the Tie-breaker method described below shall be used.
 - c. In the event of a tie for second place, plus points for/against will used to determine the second place or alternate finisher.
- 5. Nine or more entries (Pairs) / Eleven or more entries (Singles):
 - a. Two divisions will be formed by blind draw and each division will play a complete round robin (no crossover games). The teams/players with the best won-loss record in each division will play a complete game to determine the overall winner and the second place or alternate finisher.
 - b. In the event of a tie for first place after division round robin play, the Tie-breaker method described below shall be used.

Length of Games

- 1. The length of games shall be according to the length of games established by Bowls USA for competition at the National Championships. As of this edition, the length of games is 18 ends (pairs) and 21 points (singles).
- 2. A maximum of three games in Pairs and four games in Singles shall be played each day.
- 3. The participants in each event have the prerogative of changing the number of ends (18) in a Pairs event or the number of points (21) in a Singles event by a vote prior to the start of the event on the first day. All skips in a Pairs event and all participants in a Singles event shall vote. A majority vote is required for action. Once a vote has been made to change the length of games, all matches shall conform to the change, including any playoffs.

Scoring of Games and Game Decisions

- 1. Game format. All games shall be scored in "shots format" (as opposed to counting ends won) and as detailed in the latest edition of the Laws of the Sport of Bowls.
- 2. "Plus" points. Plus points for/against in each game will be determined for both plus (max of +10) and minus (max of -10) points.
- 3. Tie games. Games tied at the end of regulation will be followed by one extra end to determine a winner. Bowls USA rules regarding extra ends will apply.
- 4. Game points awarded and determining overall winner. The winner of a game is awarded one point. No points are awarded for a loss. The overall winner will be the team or individual with the most points at the conclusion of the tournament, except in cases where a playoff is necessary. The winner of the playoff is detailed in the "Tie-breaker method" or in the scenarios found in Appendix A.
- 5. Tie-breaker method (five or more entries, Pairs and Singles). If at the end of the competition, two or more teams are tied with the most number of points, a playoff game(s) will be played to determine the overall winner.
 - a. Two teams tied for first play head-to-head in a complete game

- b. Three teams tied for first the team finishing with the most plus points has a bye and plays the winner of the game between the two remaining teams
- c. Four teams tied for first the four teams compete in a two-round single knockout playoff. Based on plus points, team 1 plays 4 and 2 plays 3, and the winners play to determine the overall winner
- 6. Tie for second place. Determination of second place is necessary because the second place team/player will be the alternate representative to the National Championships in the event that the winner is unable to attend. In the case of a tie for second place (after first place has already been determined), plus points for/against will be used to determine the second place or alternate finisher.
- 7. Early conclusion of games. If the first and second place teams in a complete round robin format, or the divisional winners in a two division format, are determined before the completion of the round robin, then completion of the round robin will be canceled and playoffs will commence.

Other Rules of Play

- 1. Start of play. All players shall be available to start each match as scheduled. A penalty of one (1) point shall be assessed for lateness for each (10) minutes of lateness. A lateness of thirty (30) minutes shall be a penalty of match forfeit.
- Completion of meaningful games. All entries shall agree to complete play of all meaningful
 matches in the round robin (or in the round robin phase of divisional play), except for Leave for
 Cause (sickness, injury, death-in-family, or for some other reasonable cause), and with the
 approval of the Playdowns Coordinator.
 - a. A meaningful match is one which could affect the standings of teams that are mathematically in contention to finish first or second in a complete round robin or first in divisional play [bearing in mind that the object of the Playdowns is to select the divisional representative and alternate to the National Championships].
 - Games between entrants who are not mathematically in contention to finish first or second in a complete round robin or first in divisional play need not be played or completed.
 - c. The penalty for failure to complete all meaningful matches without approval of the Playdowns Coordinator shall be ineligibility for Playdowns participation for a period of one year in both Pairs and Singles, effective immediately upon infraction. Entrants who cannot complete a playoff or a tiebreaker in divisional play will forfeit the match, but they will not be subject to any other penalty.
- 3. *Inclement weather*. If inclement weather or other external factors causes play to be suspended before the completion of the tournament, the contestants can reschedule the completion of the event provided that:
 - a. all contestants who have meaningful games to complete are in agreement, i.e. decision must be unanimous by skips (Pairs) or players (Singles) affected by such a decision
 - b. there will be at least thirty (30) days between the completion of the rescheduled event and the start of the National Championships
 - c. otherwise, play must continue until the event is completed

Prize Money and Other Considerations

1. All entry fees are held by the Playdowns Coordinator or the division Secretary-Treasurer and paid out to the Central Division Playdowns champions as follows:

- a. The Central Division will keep a portion of each entry fee. The amount that will be kept will be determined in advance by the Executive Board
- b. Pairs representatives the winning team will evenly split the total remaining amount
- c. Singles representative the winning player will be paid the total remaining amount
- 2. The Central Division provides its representatives with the following:
 - a. A cash amount (currently \$100) for each representative if they purchase a sports jacket in the division color, providing the representative is a first time winner or if the winner has not received money for a sports jacket in the past seven (7) years.
 - b. Central Division patch or crest to affix to the sports jacket, if the winner has not previously received one
 - c. One shirt in the division color for use at the National Championships
